

In the Field

November provides South Floridians with a Fall Migration curtain call, as the last

transient songbirds journey south and our winter visitors arrive. By month-end, waterfowl diversity will reach its peak, with more than a dozen duck species joining our resident ducks; gull diversity at local beaches also increases notably.

Join one of our November field trips led by expert guides and see for yourself! New this month is our first <u>Accessible-Inclusive Birding outing</u>! TAS board member and Nature Photojournalist Kirsten Hines will lead this half-day trip at Crandon Park on Key Biscayne. This event is designed for beginning birders, particularly families with small children or strollers, people in wheelchairs, or others with mobility concerns. You can also check out our regularly-scheduled field trips to <u>Southern Palm Beach</u> and <u>Everglades National Park</u>.

Rare bird delights local Birders — Red-legged Honeycreeper reported in record numbers!



An unprecedented number of Red-legged Honeycreeper sightings in our area has enthralled the local birding community for weeks. Birders have been lighting up the local bird boards, eBird and WhatsApp chats about seeing this small songbird of the tanager family in our neck of the woods. It's normally found in the tropical New World from southern Mexico south to Peru, Bolivia and central Brazil, Trinidad and Tobago and on Cuba.

Yet 14 different birds of this species, notable for its red legs, have been discovered in seven South Florida locations spanning three counties over the last two weeks of October. Three were spotted in A.D. Barnes Park on October 26. All of the local sightings are listed in the Rare Bird Update. Other Red-legged Honeycreepers have alighted in Louisiana and Texas.

According to TAS Field Trip Coordinator Brian Rapoza, there may be hundreds of displaced honeycreepers in Florida, just waiting to be discovered. He says there's no way to know for sure exactly where these birds are coming from or why, but he believes it's most likely that they are arriving here from western Cuba, which was severely impacted by Hurricane Ian in late September. The hurricane may have disrupted the honeycreepers' food sources, forcing them to migrate north to find food. It remains to be seen if other species from Cuba will be similarly impacted. A Western Spindalis of the Cuban race, sighted in Key West last week, is the only other Cuban bird reported in Florida since Hurricane Ian swept up the Gulf Coast.

"Zombie" South Dade Logistics and Technology District application not dead yet

- next vote TODAY, November 1



The "South Dade Logistics and Technology District" (SDLT) <u>application</u> has become like the walking dead — a zombie-like proposal haunting Miami-Dade County (MDC) Commission meetings. It was actually dubbed a "zombie project" in an October 17 <u>Miami Herald Op-Ed</u>, a theme echoed by MDC Commissioner Eileen Higgins, who opposes the ill-conceived project. As absurd as it may sound, on October 18 the MDC Commission failed to deliver a final vote for a *fifth time!* What's at stake is voting down the developer's application for an industrial park to be sited beyond the existing Urban Development Boundary (UDB). The next vote takes place today, November 1.

Conservation loses if the Commission actually votes in favor of this application. A development precedent will be set that can't be undone. The protection of the Everglades and Biscayne Bay should not be for sale. Nor can Everglades Restoration be compromised, certainly not so developers can obtain cheap land with the flimsy promises of job creation.

Preview - November with the Birds 2022

Thankfully, Item 4A, a <u>procedural improvement ordinance</u> proposed by Commissioner Danielle Cohen Higgins, passed by a vote of 11 to 1 on October 18. Item 4A has the potential to end unlimited deferrals for Comprehensive Development Master plan (CDMP) amendments, including UDB modifications that fail to pass after three board votes, and end the type of application gridlock we are experiencing with the SDLTD. The ordinance, however, will still need to be reviewed by municipal officials and requires a detailed County's Mayor Report before final approval and implementation. We will keep you posted.

Bird Collision Data Collectors urgently needed



Fall Migration winds down this month as millions of birds heading south for the winter pass through South Florida. Because migrating birds generally rest and forage during the day and travel at night using the stars as navigational aids, brightly lit cities impede their night vision, steer them off course, and can confuse and disorient them, often causing deadly collisions. Sadly, millions of birds are lost to building collisions in the U.S. each year.

To lower the mortality rate, TAS's <u>Light's Out Miami</u> initiative urges homeowners and building managers to turn off or block non-essential lights from 11 p.m. to 6 a.m. through November 15 to protect migratory birds traveling through our region.

Bird Collision Data Collection volunteers are urgently needed to search for birds who have been injured or killed by colliding with buildings. Data collected anywhere in Miami-Dade County is of value, but most needed are volunteers to monitor the Brickell, Downtown and Biscayne Boulevard corridor, as well as areas such as Aventura, Coconut Grove and Coral Gables business districts, Downtown Dadeland, Miami Beach and any other communities with a concentration of tall buildings where collisions are highly likely.

Fall Migration "Extravaganza" at Cape Florida Banding Station



The Cape Florida Banding Station (CFBS) celebrated its 20th Anniversary on October 5, highlighted by the banding of a vibrant Summer Tanager (pictured above). The Station's milestone month would prove record-breaking. CFBS Director Michelle Davis reports that the station experienced a "migration extravaganza" when a strong cold front brought scarcer species, including Magnolia, Tennessee and Bay-breasted Warblers — species that were reported in higher numbers than usual for October across the Florida peninsula!

Among October's highlights:

- CFBS broke its American Redstart banding record with 375 birds banded, surpassing the 368 banded in 2020! Read the blog post here.
- The Station banded a Bobolink, a common migrant, yet this one was only the second banded by CFBS over 20 years. Read the blog post here.
- October 19 was a banner day with 210 birds banded, including a male Common Yellowthroat originally banded in 2020 in Vermont. Read the blog post here.
